Came on for hearing *The Emergency Motion By the United States Trustee's for the Appointment of Chapter 11 Trustee under 11 U.S.C. § 1104(a), or to convert case to Chapter 7 under 11 U.S.C. § 1112(b)* [docket no. 415] on February 19, 2010. After considering the Motion, the responses, joinders, any reply, evidence presented, proffered, or adduced, the Court stated its findings of fact and conclusions of law on the record in open court pursuant to Bankruptcy Rule 7052 and 9014(e), the Court finds that good and sufficient cause exists for

granting the relief concerning the appointment of a Chapter 11 Trustee and denial of all other relief requested therein; accordingly, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:

1. The Motion is **GRANTED** as specified herein;
2. In accordance with 11 U.S.C. § 1104(d), the United States Trustee shall promptly confer with the parties in interest in the Cases and forthwith appoint a chapter 11 trustee for the bankruptcy estates;
3. Following the appointment of the chapter 11 trustee, the United States Trustee shall promptly file an application for approval of the appointment in accordance with the provisions of Bankruptcy Rule 2007.1(c); and
4. Relief requested in the Motion is denied if not expressly granted in this Order.
